ITEM 4 - EXECUTIVE DIRECTOR'S ORAL REPORT

Wendy Saunders reported the following:

- The Board Room will be refreshed next month in time for the February Board meeting, with new furniture and audio/visual system.
- Downtown Sacramento Partnership: The Downtown Sacramento Partnership hosted the State of the Downtown breakfast last Tuesday. There was a great speaker from Seattle that talked about how to get growth right and avoid the problems that have resulted from rapid growth, and to focus on improving parks, gathering places, overall walkability, public transit, and building housing. There was also an announcement that Kaiser had closed on the purchase of land at the railyards, and they announced Ron Burkle's investment in the Sacramento Republic soccer team and purchase of the surrounding acreage for an entertainment-related development.
- Midtown Association: A 501(c)3 was approved at the last meeting to help maintain the parks in the midtown area. Emily Baime Michaels, Executive Director of the Midtown Association, will make a presentation to the Board in March on that effort.
- Downtown Sacramento Revitalization Corporation: No update.

<u>ITEM 6 — APPROVAL TO ENTER INTO LEASE FOR 1412 16TH STREET AND PROVIDE A TENANT IMPROVEMENTS ALLOWANCE</u>

Samantha Minor from Steve Hansen's office reported that Hansen's office thanks CADA for the streetlights. The City is in the design phase to improve the baseball field and restrooms.

Member Maviglio said that there is still a homeless issue on 9th and P Street which causes people to steer clear of the area. Samantha Minor reported that the restroom is currently open for 24 hours and the office has received multiple complaints. The City removed picnic benches and will take other measures to deter this activity. Measure U funds will be used for these improvements.

- A. Downtown Sacramento Partnership: This item was reported on in Agenda Item 4.

- D. Mercury Cleaners (Northeast Corner of 16th and O Streets): Marc de la Vergne reported that DGS's consultant is currently testing the monitoring wells.
- E. Roosevelt Park Streetlights (1619 9th Street): This item was reported on in Agenda Item 7.
- F. O Street Streetscape (7th 17th Streets): Marc de la Vergne reported that staff is in the midst of completing an online survey and a link will be sent to the Board members for an opportunity to submit their comments regarding the design plan.
- G. Other Neighborhood Improvements: Marc de la Vergne reported that staff is working to wrap the utility pole with art on 14th and O outside of Table Vine. The pole is not City infrastructure, so staff is looking to place an interesting piece of art that will feature trees commonly found in the area.
- H. HCD LPR Application for Biele Place (1421 15th Street): No update.
- I. Site 21 (14th and N Streets): Tom Kigar reported that Creleigh Homes received the first round of comments from the City regarding the building permit application. The City will not issue the building permit until June or July. The DDA and purchase agreement from the State stated that the site has to close by April 26, and the building permit must be in place. Therefore, staff submitted a request to the State to close on September 12 instead, which pushes back the schedule. Staff plans to come to the Board next month for a first amendment to the DDA reflecting the extension date. Member Avdis expressed concern about this delay. Wendy Saunders stated that staff will circle back with the developer and report back to the Board. Tom Kigar reported that the generator is currently proposed to be in the garage and the developer would like to put it on the roof. Cresleigh is pricing that and comparing the cost to the revenue of the parking spaces that would be lost.
- J. R Street PBID: Todd Leon reported that the PBID Board approved a 2% increase in the PBID assessment. To keep up with inflation and provide extra funds to deal with safety issues. One focus is the hot spot for trash and nuisances generated by the Dollar Tree store. Code enforcement fined them in the past; the next fine is \$25,000. Next month PBID will provide an overall update to the Board.

- K. R Street Affordable Housing (1717 S Street): Todd Leon reported that the project is in the midst of preparing construction drawings. The team will submit the required drawings to the City in order to receive a building permit.
- L. R Street Parking Structure (8th/9th Streets): No update.
